Eye Contact	 If this product comes in contact with the eyes: Immediately hold eyelids apart and flush the eye continuously with running water. Ensure complete irrigation of the eye by keeping eyelids apart and away from eye and moving the eyelids by occasionally lifting the upper and lower lids. Continue flushing for at least 15 minutes. Transport to hospital or doctor in event of irritation. Removal of contact lenses after an eye injury should only be undertaken by skilled personnel.
Skin Contact	If skin or hair contact occurs: Flush body and clothes with large amounts of water, using safety shower if available. Remove all contaminated clothing, including footwear. Wash skin and hair with running water. Transport to hospital, or doctor in event of irritation.
Inhalation	If aerosols, fumes or combustion products are inhaled, remove affected person from contaminated area. Keep at rest until recovered. If symptoms develop seek medical attention.
Ingestion	 For advice, contact a Poisons Information Centre or a doctor at once. Urgent hospital treatment is likely to be needed. If swallowed do NOT induce vomiting. If vomiting occurs, lean patient forward or place on left side (head-down position, if possible) to maintain open airway and prevent aspiration. Observe the patient carefully. Methods and material for containment and cleaning up

Minor Spills	Control personal contact with the substance, by using personal protective equipment. Contain spill with sawdust, sand, earth, inert material or vermiculite then place in suitable, labelled container for waste disposal. Wipe up. Clean area with large quantity of water to complete clean- up.
Major Spills	Clear area of personnel and move upwind. Alert Fire Brigade and tell them location and nature of hazard. Wear appropriate personnel protective equipment and clothing to prevent exposure. Avoid breathing in mists or vapours and skin or eyes contact. Prevent, by any means available, spillage from entering drains or water course. Stop leak if safe to do so.
